## **HOW TO DONATE**

The Pentwater Historical Society (PHS) is a 501(c)(3) charitable organization. All gifts to the PHS Building Expansion Fund have the tax benefits allowed by law as charitable contributions.

The PHS established a project fund with the Community Foundation of Oceana County (CFOC) to help with gift administration and to hold campaign contributions in a money market fund. All gifts for the PHS Building Expansion Fund should go through the CFOC.

Our pledge form gives a variety of ways to donate. One-time or annual pledge amounts can be submitted via our pledge form and paid to the CFOC, an eligible 501(c)(3).

Dear Pentwater friend,

The story and the future of the Pentwater Historical Society and its museum is best illustrated by the true story of two small children. Olive and Etta visited the museum in the summer of 2021 and were fascinated by the many artifacts on display, and highlighted by the scavenger hunt that kept them moving around the museum and making new discoveries. In the days following their visit they setup a lemonade stand. From the profits they made, 50% was delivered to the museum by these smallest of visitors to help fund our work and our future.

We need your support as we plan a future that will include expanding the museum to display key artifacts that are currently in storage because our current historic building is out of room, and new exhibits that attract and educate all generations of visitors. The expanded museum will be a hub of community activity and learning. It will include:

- · Space to display key historical artifacts currently forced to remain in storage
- Event space available for the community
- Improved historical research facilities

In order to meet these goals, to benefit Pentwater's residents and its visitors, we need your help with funding to add a second building.
