a. Grants – Beth

Received the operational support grant for \$5500 in budget items (10000 requested). Also requested 1500 for tuition and received 0. Requested 500 from the PW Junior Women's Club for educational fund which is pending. The ARPA grant and PW Junior Women's Club for the building stories exhibit are also outstanding. There will be a CFOC wish list in 3 separate price ranges to think about if you need for the Museum or software fees or equipment or other needs up to 500, 1500 or over 1500 price range. We also have a woman that would do a video about what's in the Museum or a fundraising video or a videographer from WSCC. The woman is also willing to do the fundraising video for 1975\$.
